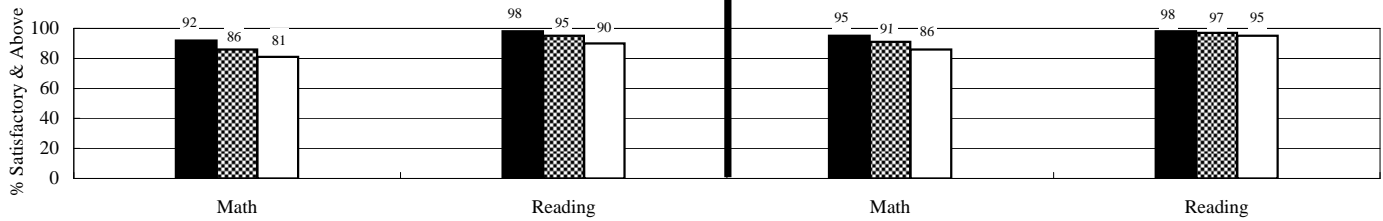

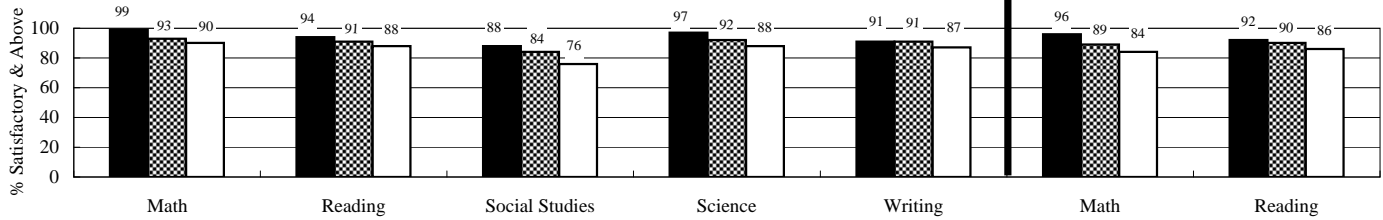

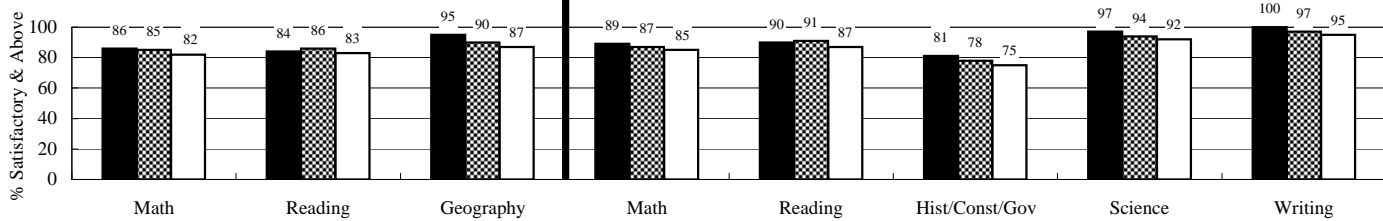
5th Grade Tests *

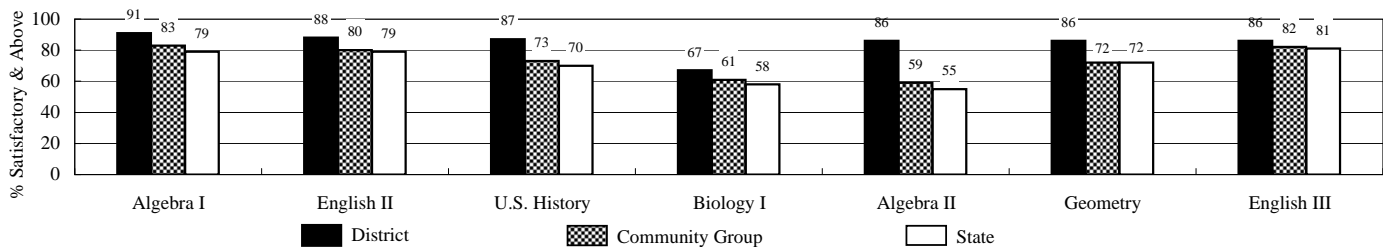
